# Child Care Landscape Report

## Introduction

Child care is an essential workforce support. Understanding the child care landscape in a particular county enables communities to assess and address child care needs. Access to safe, affordable, quality child care enables families to participate in the workforce and raise contributing members of the community. There are both immediate and long-term positive impacts.

This report provides an overview of the current child care landscape for each county in Kentucky, detailing the numbers and types of regulated child care as well as the overall capacity (slots) per county, Child Care Assistance Program (CCAP) participation and enrollment, and total number of programs operating at high quality (Levels 3-5 in KY All STARS, Kentucky's Quality Rating System).

Using census data based on the most recent population estimates from July 1, 2023 at [www.census.gov](http://www.census.gov) and the Center for American Progress' definition of a child care desert – “more than three times as many children as there are child care slots available,” this report identifies both child care deserts and high quality child care deserts.

- **Child Care Desert** – *More than three times as many children as there are child care slots available.*
- **High Quality Child Care Desert** – *High Quality is defined as a center/home at KY All STARS Levels 3-5 with a desert being more than three times as many children as there are high quality child care slots available.*


## Suggestions for Use

- **Certified Family Child Care Home** - Services are provided in the individuals home for a maximum of 6 unrelated children. They may also care for 4 related children, for a maximum of 10 children. They must have an assistant if they care for more than 4 infants, including their own or related infants.
- **Child Care Desert** – More than three times as many children as there are child care slots available.
- **High Quality Child Care Desert** – High Quality is defined as a center/home at KY All STARS Levels 3-5 with a desert being more than three times as many children as there are high quality child care slots available.
